Tuesday, April 16, 2019 (Las Positas College)	Regular Board of Trustees meeting: New trustee swearing-in ceremony

In order to be considered for appointment to Trustee Area 5 (Dublin/Pleasanton/Sunol), all application materials must be received in the Chabot-Las Positas Community College District office, via our online form or via mail, no later than Tuesday, March 26, 2019, 4:00 p.m.

Application materials must include the following:

- A letter of interest addressed to the president of the Board of Trustees, Mr. Edralin J. "Ed" Maduli
- A resume, including community service and leadership experience
- A completed application

IMPORTANT: Before applying, please confirm residence within the Trustee Area 5 geographic boundaries. Boundary information can be found on the Alameda County Government website. Applications will not be accepted without all application materials included in your final submittal.
