State Budget: Big Picture

- > \$85.9 billion General Fund expenditure
- Majority-vote budget (Prop 25)
- > Triggers mid-year cuts to education and other programs
- Solves \$26.6 billion gap identified in January

State Budget: Big Picture — Continued

Major Solutions:

- > \$11.1 billion in expenditure reductions
- > \$11.8 billion in baseline revenue adjustments
- > \$2.9 billion in borrowing, shifts, and fund transfers
- > \$1 billion in new revenue changes (e.g. new and extended fees, revenue collections)
- > \$0.5 billion in local realignment revenue impacts

State Budget: Details

- \$150 million in cuts to each, University of California, California State University systems
- \$150 million cut to state courts
- \$200 million in "Amazon" online tax enforcement
- \$2.8 billion in deferrals to K-12 schools and community colleges
- \$300 million from \$12 per vehicle increase in DMV registration fee
- \$150 million from fire fee for rural homeowners
- \$1.7 billion from redevelopment agencies
- \$1.2 billion in higher May and June revenue

State Budget: Impact on California Community Colleges

- \$400 million base reduction (workload reduction)
- Increase in student fees of \$10 per unit (from \$26/unit to \$36/unit)
- 0% COLA (statutory COLA is 1.67%)
- Apportionment deferrals continue with a new deferral of \$129 million from Spring 2012 to October 2012
- Extend categorical flexibility through 2014-15

State Budget: Impact on California Community Colleges

Department of Finance will certify in January whether \$4 billion projection is accurate. The "trigger" cuts are essentially in three tiers, based on how much of the extra \$4 billion comes in.

For community colleges:

- Tier 0 (less than \$1 billion): No cuts
- Tier 1 (\$1-2 billion): \$30 million apportionment cut, backfilled by an increase in fees of \$10, to \$46/unit
- Tier 2 (\$2+ billion): Tier 1 cut and fee increase PLUS a \$72 million additional apportionment cut (workload reduction assumed)

State Budget: Impact on Chabot-Las Positas Community College District

- Adopted budget with less than \$2 billion of new revenue, causing triggers to be pulled
 - \$387 million net reduction to apportionment
 - \$362 million net budget cut plus \$25 million fee shortfall

Chabot-Las Positas Community College District
Apportionment reduction: -\$5,922,000 (6.9%)

Outlook for Chabot-Las Positas Community College District

- > State: revenues coming in below projected July <\$539 million
 - Possible mid-year cuts
- Nation: market volatility
- Must work together towards a balanced budget
