## **Addendum No. 1** **INVITATION FOR BID NO.: 13-01** **TV Recording Studio Upgrade to HD, Chabot College**

All Prospective Bidders:

This addendum is issued to clarify, add, delete, correct and/or change the bidding documents to the extent indicated and is hereby made a part of the above noted bid documents on which the contract will be based. Any modifications/changes made by this addendum affect only the portions or paragraphs specifically identified herein; all remaining portions of the proposal to remain in force. It is the responsibility of all bidders to conform to this addendum.

Acknowledge receipt of this addendum in the space provided on the bid signature form (1.2 Acknowledgment of Bid Addenda). Failure to do so may subject Bidder to Disqualification.

The original Bid Documents are modified by the revision as follows:

1. **NOTICE of MODIFICATION and/or CHANGE:**
  - a. **BID OPENING CHANGED in SECTION B – NOTICE TO BIDDERS-**  
**Bids are now due: TUESDAY, AUGUST 28, 2012 at 2 PM.**
  - b. **PRE-BID JOB-WALK:**
    1. **MODIFICATION:** SECTION B – NOTICE TO BIDDERS AND SECTION C – INSTRUCTION TO BIDDERS. Modification to a “Mandatory, Pre-Bid Job Walk” to a “**RECOMMENDED**, Pre-Bid Job Walk”.
    2. **DELETE** sentence, “If a Bid Proposal is submitted by a Bidder whose representative(s) did not attend the entirety of the Mandatory Job Walk, such bid will be rejected by the District as being non-responsive.”
    3. **DELETE** item (c) Mandatory Job Walk Form under SECTION C – INSTRUCTION TO BIDDERS, ITEM 6. Documents Accompanying Bid.
2. **NOTICE OF CLARIFICATION and/or CHANGE:**
  - a. **CLARIFICATION in SECTION D – BID & SIGNATURE FORM ITEM DESCRIPTION-** The Studio Kit for the JVC GY-HM790U Studio Configuration HD Camera System (Line Item 3) must include the w/14X lens, CCUs, Camera Cable(s), (for Focus and Zoom) and a Studio Viewfinder.

- b. **CLARIFICATION in SECTION D – BID & SIGNATURE FORM:**  
The TOTAL Price of the Bid must include On-Site Installation with all necessary parts with no substitutions. An On-Site visit is highly recommended to verify that all installed equipment is running properly; that it works with existing equipment; that the power connections are properly hooked up to the Teleprompters; and that the video switching is seamless with the existing Broadcast Pix 5000 switcher upon completion.
