

FREQUENTLY ASKED QUESTIONS

About Bidding a Project

Q. *Where can I find information about Bid No. 20/21-14?*

A. Information will be made available on the District's website. To access the site go to <http://www.clpccd.org/business/open.php> Under Bidding Opportunities, Invitation to Bid, find the applicable project – **BID NO.: B20/21-14 CHABOT COLLEGE DENTAL HYGIENE SIMULATION EQUIPMENT CONNECTIONS**

Q. *What is the scope for this project?*

A. Provide and install new electrical, low voltage and plumbing systems for new dental simulation equipment. The new dental simulation equipment will also require the installation of a new exterior rated compressor on a new concrete pad. Compressor is to be housed by a chain-link fence with slats and a roof. Installation of dental simulation equipment to be done by District.

Q. *What is the Engineering Estimate for this project?*

A. The estimate for the Dental Hygiene Simulation Equipment Connections is **\$400,000**.

Q. *What does the bid document consist of?*

A. The bid document consists of District's Div. 00 and 01; and WKM's technical specifications, and drawings. The reference documents provided are for informational use.

Q. *Will there be a MANDATORY WALK for this project?*

A. Yes. General Contractors are **REQUIRED** to attend the Pre-Conference and Job Walk on **Wednesday, April 28, 2021 at 10:00 AM**. All participants are required to sign-in at the Pre-Bid Conference and Job Walk and provide business cards including e-mail address. Bidders are to meet at Chabot College campus, 25555 Hesperian Blvd., Hayward, CA. Facilities Management Office, adjacent to Building 3000. Failure to attend or tardiness will render bid ineligible.
