# **INVITATION TO BID 10-05 CLPCCD NETWORK INFRASTRUCTURE EQUIPMENT**

## **SECTION A – BACKGROUND AND REQUIREMENT**

Chabot-Las Positas Community College District (CLPCCD) is preparing for a major technology upgrade at both college campuses as part of the planned Measure B improvements. Part of this upgrade is the installation of new network switching and routing equipment to replace aged equipment.

In this document, CLPCCD is requesting sealed pricing bids from qualified vendors who can provide switch configurations listed.

**The first requirement is that Bidders must submit bids for all equipment configurations listed herein (See Section D - Specifications and Scope of Products to be Provided).**

Bids must be addressed and delivered to and inquiries concerning the purchasing process are to be directed to the person listed on the cover page of this Bid.

All inquiries regarding the technical information are to be directed to Jeannine Methe at (925) 485-5213.

## **SECTION B – STANDARDS AND PURPOSE**

For several years, the CLPCCD network has been standardized on Cisco 7507, 3620 and 7206 routers, and Cisco 550x, 2924 and other models of switches with cascaded hubs. The current network equipment is unable to support the performance and functionality requirements needed for the computer-intensive teaching environment planned over the next several years. With the Measure B funding, CLPCCD is able to upgrade the aging and obsolete hub and switch configurations at the campuses. The intent of the new equipment configurations, as described in this Bid, is to provide a fully functional network system ready for use by CLPCCD.

The purpose of this bid is to establish a purchase agreement between CLPCCD and the selected vendor to purchase network equipment meeting the District Standards at competitive bid pricing.

Bidders are encouraged to investigate and provide all possible educational, quantity and other discounts.

Quantities are segregated by switch type so bids can be assessed independently as well as collectively.

## SECTION C – NOTICE TO BIDDERS

Notice is hereby given that the Board of Trustees of the Chabot-Las Positas Community College District, State of California, hereby calls for sealed bids to be delivered to the Manager, Purchasing and Warehouse Services, 5020 Franklin Drive, Pleasanton California 94588 until June 3, 2005 at 2:00 p.m. at which time and place the bids will be opened for the CLPCCD Network Infrastructure Equipment. Faxed or E-mailed bids will not be accepted.

Bids shall be presented in accordance with the specifications for the same, which are on file with the Manager, Purchasing and Warehouse Services Department at the office address listed above.

The Board of Trustees reserves the right to reject any and all bids or any and all items of such bids.

This bid shall also be subject to any and all applicable laws, regulations and standards.

## SECTION D - SPECIFICATIONS AND SCOPE OF PRODUCTS TO BE PROVIDED

CLPCCD has specified an equipment list built around Cisco network equipment that will meet the long-term needs of the campuses. A summary of the equipment list is shown below and the equipment location is provided for reference only.

The Bid Forms in Section E itemize a summarized list of components which must be priced in the bid. The Bid Forms in Section E include the detail switch configurations with quantities that must be bid for “Configuration 1 through 5”. The equipment configurations in the lists are intended as a complete solution. Any item not specifically called for in the equipment list, but normally required for a complete system, should be separately noted in the Optional Table of Section E Bid Forms and these items should be considered as part of the complete solution.

Refer to Equipment Special Support Requirements in Section F for the 3-year Smartnet Support requirements to be bid as part of the product price in “Configurations 1 through 3”.

**Bidders must complete all “Bid Forms” in Section E and substantially conform to the configurations. Separate bid forms are provided for each switch type “Configurations 1 through 5” and for Trade-in Credits “Configuration 6”.**

#### **EQUIPMENT TRADE-IN**

An additional Bid Form in Section E “Configuration 6” must also be bid to identify the total Trade-in Credit for the Cisco equipment being replaced. In preparing the bid response, bidders must take advantage of all Cisco trade-in programs, specials and discounts that would provide CLPCCD with a more favorable purchase price. **While it is the intent of CLPCCD to award this contract and issue a purchase order no later than July 1, 2005, all special pricing that is time-limited must be clearly detailed in the bid response.**

CLPCCD intends to supply the existing end-of-sale and end-of-life equipment to be used for trade-in credits against the purchase of new Cisco switches. The detailed equipment list of the existing equipment is included in Bid Form “Configuration 6”. Bidders are expected to investigate all promotional programs and pricing options, in order to present the best pricing alternative to CLPCCD in the bid response.

#### **PERFORMANCE GUARANTEE**

The acquisition of this switching equipment represents a huge undertaking by CLPCCD. CLPCCD is not in a position to be able to troubleshoot and solve problems generated by unstable code, “undocumented features” or other engineering incompatibilities. We are looking to purchase a stable, proven technology that will perform flawlessly in its initial implementation, while providing growth capacity for the future CLPCCD expansion.

As such, CLPCCD requests a letter from Cisco, verifying that the equipment listed in the Bid Forms, will perform 100% to their written specifications. If not the case, Cisco will be responsible for all troubleshooting, debugging and problem solving efforts, providing CLPCCD with timely workarounds including alternate products or loaner hardware until a stable technical solution is found. In the event that Cisco cannot make the product work as specified, Cisco will provide CLPCCD a full refund, of all purchase costs, including product and installation costs, as well as compensation for the time and effort that CLPCCD staff and their consultants have invested into the deployment.

#### **EQUIPMENT LIFE CYCLE**

The equipment list has been created using the available configuration tools, brochures and price lists that detail currently available, deliverable products. With this sizeable equipment purchase, it is extremely important that CLPCCD not select any equipment that is nearing obsolescence or that will be soon replaced with superior models. To that end, CLPCCD is requesting consideration for the following:

- 1) A letter from Cisco describing the intended product life cycle for each type of switch that is listed in the Bid Forms.
- 2) A letter from Cisco guaranteeing a free bundled hardware upgrade, if a relevant chassis and card upgrade is released in the three months following each phase of the equipment procurement. In particular, CLPCCD would be interested in upgrades that require hardware changes in order to take advantage of improved backplane speeds or switching fabric, higher Gigabit port densities and more intelligent management module functionality.
- 3) In the later deliveries of the phased plan, as described in Section G under Shipping/Handling and Delivery Schedule, CLPCCD would be interested in substituting newer switch models, of comparable cost, or taking advantage of price decreases and “specials” that may apply to those equipment models listed in the Bid Forms. We require a guarantee in writing from Cisco or the Supplier/Integrator that these options would be offered to CLPCCD.

1. **Entire Agreement:** The following terms and conditions, together with such terms as are set forth in this Purchase Order ("Order"), such plans, specifications or other documents as are incorporated by reference in the Purchase Order, and any amendments in any subsequent authorized writing from District, shall constitute the entire contract between the District and Seller and shall supersede all prior agreements, understandings, negotiations and discussions, whether oral or written, of the parties. There are no warranties, representations or other agreements between the parties in connection with the subject matter hereof, except as specifically set forth herein. If performance specifications, technical product descriptions or other similar descriptive materials submitted by Seller in connection with the Order have been incorporated by reference in the Purchase Order these shall not be deemed to supersede any contrary requirements of District, but to the extent that such materials are not inconsistent with District's requirements, they shall constitute a part of the basis of this agreement.
2. **Payment:** Payment terms are as set forth in the Purchase Order. . 23. **Attorney's Fees:** If a party to this Agreement brings any action, including an action for declaratory relief, to enforce or interpret the provision of this Agreement, the prevailing party shall be entitled to reasonable attorneys' fees in addition to any other relief to which that party may be entitled. The court may set such fees in the same action or in a separate action brought for that purpose.
24. **Captions:** The captions used herein as headings of the various paragraphs and subparagraphs hereof are for convenience only, and the parties agree that such captions are not to be construed as a part of the Agreement or to be used in determining or construing the intent or context of this Agreement.
25. **Counterparts:** This Agreement may be executed in any number of counterpart copies, all of which shall constitute one and the same Agreement and each of which shall constitute an original.
26. **Severability:** If any of the provisions or portions thereof of this Agreement are held to be unenforceable or invalid by any court of competent jurisdiction, the validity and enforceability of the remaining provisions or portions thereof shall not be affected thereby.
