The Chabot-Las Positas Community College District is requesting that the following issues be reopened for 2022:



Subject: Acceptance of Grant Award Agreement - Kaiser Permanente Northern California Community Benefit Programs, Chabot College

Background: CalFresh enrollment is an important aspect of supporting basic financial stability. While some students attend Chabot College's food pantry services, this often is not enough. CalFresh enrollment can serve as a much more sustainable and stable means for addressing food insecurity, with the food pantry supplementing this resource. Grant objectives focus on increasing student enrollment in CalFresh and the CalFresh Employment & Training (E&T) Program, as part of the services provided by the new Chabot College SparkPoint Center, comprehensive resource hub.

The CalFresh Employment & Training Program will target Special Program students, particularly RISE (formerly incarcerated) and Guardian Scholar students, in the Welding, Medical Assisting, Machine Tool, and Industrial Technology Electronics Career Technical Education (CTE) programs. Funding supports enrolling students in CalFresh programs and provides students with basic needs support (e.g., books, transportation, supplies, tools, uniforms, etc.) to ensure students have the resources they need to succeed in their education.

Funding for the project is in the amount of \$25,000 for the period of October 1, 2021 through June 30, 2022.

Recommended Action: That the Board of Trustees accepts the proposed Grant Award Agreement - Kaiser Permanente Northern California Community Benefit Programs in the amount of \$25,000 for the period of October 1, 2021 through June 30, 2022. It is further recommended that the Board authorize the Vice Chancellor, Business Services, to execute the grant award agreement on behalf of the District.

Background: Cabrillo Community College is the BACCC Fiscal Agent to Chabot Community College District, Las Positas College and is responsible for distribution of the regional share of SWF to Las Positas College. The Strong Workforce Program allocates \$248M per year for the purpose of expanding the availability of quality community college career technical education and workforce development courses, programs, pathways, credentials, certificates, and degrees. The legislation provided for 40% of the funds to be distributed through and allocated by the regional consortia to their member colleges for the purpose of funding regionally prioritized projects and programs that meet the needs of local and regional economies. The original agreement was approved by the Board of Trustees on October 20, 2020.

Chabot Las Positas Community College District, Las Positas College will invest the allocation of the Strong Workforce Program Regional Share fiscal year 21/22 funds in the following program areas:

Work Based Learning

Public Safe/Fire Academy

Earn & Learn

Teacher Preparation Pipeline

Career Center Coordination

Job Development


Subject: Approval of Contract Renewal Amendment and Side Letter to Contract —
Alameda County Social Services Agency, Children and Family Services for the
Community Action to Reach Out to Infants (CARI) Program, Chabot-Las Positas
Community College District, Chabot College

Background: Chabot College has received notification from the Alameda County Social Services Agency of its intent to renew a grant for the continuation of services for the Community Action to Reach Out to Infants (CARI) Program.

Under the CARI Program, the College provides specialized, pre-designed training for potential Resource Families (previously Foster Parents, Kinship Caregivers) and Respite Providers to care for children that enter Alameda County's Child Protective Services through drug exposure, HIV, neglect or abuse. This will be the eighteenth year the Alameda County Board of Supervisors has chosen to reconfirm its dedication to the ideals of service to the community through the maintenance of this partnership with the College.

The Alameda County Social Service Agency will recommend for approval, to the Alameda County Board of Supervisors, the grant renewal amount of \$39,797.00. The contract is effective for services rendered from July 1, 2021 – June 30, 2022. The Board of Trustees initially approved this grant in 2003, as item 4.2 of the August 19, 2003 meeting agenda. The most recent renewal was in 2021, under item 4.2 of the March 16, 2021, meeting agenda.

Subject: Receive and File the Chabot-Las Positas Community College District Annual Financial and Compliance Audit for the Fiscal Year 2020-21

Background: The June 30, 2021 annual audit report is being presented to the Board of Trustees for review and acceptance. This annual financial and compliance audit is required under Education Code 84040 and provides for an examination of the District's annual financial statements to assess their fairness and reliability.

The unmodified audit opinion rendered by Crowe LLP communicates that the District's financial statements, as presented within the audit report, present fairly the financial position of the District for the fiscal year ended June 30, 2021. The management discussion and analysis section of the audit report contains an executive summary of the results of operations for the fiscal year ending June 30, 2021.

Section 13e of the U.S. Office of Management and Budget Circular A-128, Audits of State and Local Governments, also requires that the audit report be made available by the State or local government for public inspection within thirty days after the completion of the audit.

Also included for the Board of Trustees review and acceptance are the bond financial and performance audits for Measures A and B. These will also be presented to the Bond Oversight Committee at a later date.



The District issued a request for proposal RFP B21/22-03 on September 24, 2021, seeking qualified General Contractors in an open solicitation. These scores were combined with the technical scores and the highest ranked firm is being recommended for award of the pre-construction services contract to Blach Construction Company of San Jose, CA as the top-rated firm for this RFP.


