BACKGROUND INFORMATION -

Chabot College has received notification from the Alameda County Social Services Agency of its intent to renew a grant for the continuation of services for the Community Action to Reach Out to Infants (CARI) Program.

Under the CARI Program, the College provides specialized, pre-designed training for potential Resource Families (previously Foster Parents, Kinship Caregivers) and Respite Providers to care for children who enter Alameda County's Child Protective Services through drug exposure, HIV, neglect, or abuse. This will be the nineteenth year the Alameda County Board of Supervisors has chosen to reconfirm its dedication to the ideals of service to the community through the maintenance of this partnership with the College.

The Alameda County Social Service Agency will recommend for approval, to the Alameda County Board of Supervisors, the grant renewal amount of \$41,200. The contract is effective for services rendered from July 1, 2023 – June 30, 2024. The Board of Trustees initially approved this grant in 2003, as item 4.2 of the August 19, 2003, meeting agenda. The most recent renewal was in 2022, under item 4.7 of the October 18, 2022 meeting agenda for \$39,977.

BACKGROUND INFORMATION -

Chabot-Las Positas Community College District has been contracting with Alameda County Social Services Agency, Children and Family Services providing pre-service training programs for many years. The State developed a uniform name and requirements for all State pre-service training programs beginning January 2017. The services requested for the 2023-24 school year remain essentially the same as the past several years.

Training classes were traditionally offered in person, which required childcare, food, and various learning materials. Because of Covid-19, most classes pivoted to Zoom. Now, caregivers have both online and in-person options and childcare will be reintroduced in 2023-24. CPR classes are required and have remained in-person.

The Resource Family Approval (RFA) classes inform and prepare potential foster and adoptive parents in making successful, permanent connections with foster youth. These classes are now required for resource families who were formerly known as adoptive parents, foster parents, kinship families and guardians. Classes are also available to respite providers and the general public who are interested in understanding the needs of children in out-of-home care, and are under the protection of the Department's Foster Care System.

The Alameda County Social Service Agency will recommend for approval to the Alameda County Board of Supervisors, the preliminary grant renewal amount of \$288,900 for the period of July 1, 2023 through June 30, 2024. The most recent renewal was in 2022, under Agenda Item 4.12 of the October 18, 2022 meeting agenda for \$279,040.

This is a new apprenticeship program with the District. Instruction for the program will be provided at the AC Transit Hayward Training Center through Chabot College. Apprentices will earn a Certificate of Achievement in Heavy Coach Mechanics from Chabot College with an Associate degree pathway, in addition to a Certificate of Completion from the California Department of Apprenticeship Standards.

The Agreement states that the Economic Development and Contract Education Department (EDCE) shall administer the Heavy-Duty Coach Mechanic Apprenticeship Program for the purposes of providing Related and Supplemental Instruction (RSI) and other services. The Agreement states that EDCE shall retain 17% of the RSI payment from the California Community Colleges Chancellor's Office (CCCCO), and any costs associated with this program that are not covered by RSI funding will be reimbursed by the Program Sponsor. The initial term of this Agreement commences on July 1, 2023, through June 30, 2025, with an option for an automatic annual renewal for up to a total of two (2) years.

BACKGROUND INFORMATION -

To continue work serving unemployed and under-employed persons in our area, the Tri-Valley Career Center (TVCC) has been awarded a Workforce Innovation and Opportunity Act (WIOA) grant in the amount of \$176,000, for program year 2023-2024 for the Adult and Dislocated Workers' Programs. WIOA funds improve workforce quality, reduce welfare dependency, and enhance the productivity and competitiveness of the nation.

Previous WIOA contracts have been with the Alameda County Workforce Development Board (ACWDB). However, the ACWDB has altered their funding to a single source Career Services Collaborative Lead, which is Ohlone College. Thus, TVCC will continue to subcontract the services through Ohlone College for this fiscal year. The services remain the same, with a new and welcomed emphasis of increased collaboration with Chabot and Las Positas Colleges.

TVCC will utilize WIOA funds to increase the employment, job retention and earnings of adult and dislocated workers, as well as increase their occupational skill attainment. TVCC works with the Colleges and community to serve local adults seeking career assistance.

The Board of Trustees has accepted similar funds for the TVCC, including item 7.2 on 10/3/17; item 7.9 on 8/21/18; item 7.1 on 9/17/2019; item 7.2 on 7/21/2020; item 7.8 on 7/20/2021 and item 7.1 on 8/16/2022.

They are being presented at the October 17, 2023 Board Meeting as a second read, and for consideration of approval.

Once approved, these value statements will be adopted for the period of 2023-2026.
