- 1. Please tell us about yourself and your accomplishments.
- 2. Please tell us why you would like to be a member of the Chabot-Las Positas Community College District Board of Trustees.
- 3. Please describe your public service and community involvement, and the skills you would bring to the Board.
- 4. Service to the Board requires a significant amount of time for meetings, studying issues and other activities. How much time do you anticipate you will have to devote to the Board and what other commitments do you have?
- 5. What is your understanding of the mission and purposes of the Chabot-Las Positas Community College District and each of its two colleges?
- 6. What do you see as the major challenges facing this district at the present time?
- 7. Whom would you feel you are representing if you are appointed to the Board of Trustees?
- 8. What is your understanding of the primary responsibilities of the Board in a multi-college district? What in your opinion is the role of a trustee?
- 9. Please discuss your understanding of the differences and responsibilities of the chancellor, the two college presidents, and their respective staffs as these relate to the responsibilities as a Board Member?
- 10. What do you see as your responsibility in assuring quality performance in the District? What is your role in assuring that all staff performances are properly evaluated?

- 11. Can you describe a few major accomplishments of the District and its colleges in the past few years? Can you identify areas for improvement that the Board should address?
- 12. The district has just "gone out to bid" for gymnasium equipment for Las Positas College. Your son, Bob, was the successful bidder and was awarded the contract subject to Board approval. The Board will vote on the contract at its first meeting in September. Explain what you would do, if anything, when the matter came up for approval.
- 12. Is there anything else that you would like to say?
