Chabot College Photography students spoke to the Board with concerns regarding cuts to the department.

ADMINISTRATION OF OATH OF OFFICE

Trustee Mertes administered the Oath of Office to Chabot College Student Trustee Yvette L. Nahinu.

PUBLIC HEARING: 2010-11 BUDGETS – GENERAL FUND, CAFETERIA FUND, CHILD DEVELOPMENT FUND, CAPITAL PROJECTS FUND, SELF-INSURANCE (RUMBL) FUND AND MEASURE B FUND

The Public Hearing for the 2010-11 Budgets was opened, and hearing no comment, the Public Hearing was closed.

PRESENTATION: 2010-11 BUDGETS – GENERAL FUND, CAFETERIA FUND, CHILD DEVELOPMENT FUND, CAPITAL PROJECTS FUND, SELF-INSURANCE (RUMBL) FUND AND MEASURE B FUND

Mr. Legaspi reported that there was a handshake deal last Friday between the "Big Five", the Governor and the four legislative leaders. Even as of today, there are no details available. What he has been able to decipher as compared to the May Revise is as follows:

The deficit is \$19.1 billion, the same as in the May Revise.

Solutions in May Revise included:

Budget cuts of approximately \$12.2 billion;

Federal Funds of \$3.4 billion:

Borrow and shift funds of \$2.6 billion;

New revenues of approximately \$.9 billion;

Solutions today include:

Budget cuts of approximately \$7.5 billion;

Federal Funds of approximately \$5.0 billion;

New revenues of approximately \$2.3 billion;

Sale of 11 state properties amounting to approximately \$1.2 billion;

Suspension of corporate tax deductions for at least two years;

Suspension of Proposition 98

Mr. Legaspi noted that the above recent solutions make him nervous; as the deal is a "proverbial house of cards", and that they are making assumptions that may not come to fruition.

Mr. Legaspi noted that the Governor was able to get what he wanted, including:

Reducing pension benefits for future state employees;

Pay cuts for current state employees;

Placing a ballot measure on the 2012 ballot that would address a rainy day fund for the state;

He reported that the floors in the House are supposed to vote on the budget package on Thursday, October 7. At that time, we should see more details and what this budget means for Community Colleges.

Mr. Legaspi presented a PowerPoint Presentation of the 2010-11 Budgets. He reported that this presentation was based on the May Revise. The presentation included:

- Governor's Budget Package;
- District Enrollment;
- Projected Changes in Revenues and Expenditures;
 - > Total increase in Revenue of \$665,000
 - > Total increase in Expenditures of \$2,629,011
 - ➤ Net increase in Expenditures of \$1,964,011
- The "Squeeze" to Supplies and Services Budgets;
 - ➤ Supplies, Services, Equipment, Transfers \$11,229,289 (11%)
 - > Academic Salaries \$40,707,100 (41%)
 - ➤ Classified Salaries \$22,386,728 (23%)
 - Fringe Benefits \$24,162,616 (25%)
- Cost of Employee Benefits;
- Budget Summary;
 - Source of Funds/Use of Funds
 - ➤ General Fund
 - Chabot College
 - ➤ Las Positas College
 - Other District Funds (RUMBL, Cafeteria Fund, Child Development Fund, Capital Outlay Projects Fund, Property Sale Fund, Measure B Fund)
- Looking Ahead

Mr. Legaspi highlighted that in 2009-10, the District served 18,754 students and was funded for 16,861, a difference over cap of 1,893 or \$8.5 million for which the District did not get funded. In 2010-11, our target and funded enrollment is 17,042; and based on Summer and Fall, our projected enrollment is already at 18,155.

Mr. Legaspi recognized and expressed his appreciation to his staff, Barbara Yesnosky, Judy Hutchinson, Rita Brown, and Pushpa Swamy.

Trustee Vecchiarelli questioned the projected amount from solar energy to the budget; savings vs. expenses.

Trustee Vecchiarelli also questioned the dollar amount the District spends on employee medical expenses vs. what other Districts spend. In addition, he questioned the amount of employee contributions in other Districts vs. in this District.

Ms. Sharon Gach questioned the percentage of education that is funded by tuition.
