Trustee Maduli stated when the Vice Chancellor did a Risk Assessment of the District, this was based on figment in the 19 areas that were evaluated. He stated our fiscal year items are moderate. He referenced page 59, Exhibit D stating it was a very important document, adding the conclusion is a moderate risk. He stated we are carrying a deficit at Chabot College even though it is decreasing. He expressed concern regarding M&Os expenditures which are high and asked how we are going to make that department whole and maintain it. Vice Chancellor Gerhard answered "yes", they are monitoring the accounting and steps are being taken. He added they don't anticipate ending the year with a deficit in both Child Development and M&O. Trustee Maduli stated Child Development and M&O are his main concerns.

Trustee Gelles asked if a plan is in place for each year. Vice Chancellor Gerhard stated "yes".

Trustee Randolph thanked Vice Chancellor Gerhard and his staff for the detailed report.

Chabot College Faculty, Senate President, Mr. Mon Khat reported on the following items:

He stated they approved the PB & AP on the half unit limit and are reviewing the District Goals for adoption.

Las Positas Academic Senate President, Ms. Melissa Korber reported on the following items:

She thanked Vice Chancellor Gerhard and Interim Chancellor Susan Cota for attending their meeting last week providing insightful information on the budget. She also thanked President of Chabot-Las Positas Faculty Association, Mr. Dave Fouquet for attending and discussing the new budget process. She stated a presentation too was given on the new Fire Academy which a vote will be taken at their next meeting.

Lastly, similar to Chabot College they too are reviewing their Visions for Success Goals, Academic Renewal, and Student Rights Grievances.

2.2 PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES AND DISTRICT CLASSIFIED SENATES

Chabot College Classified, Senate President, Ms. Noell Adams reported on the following items:

She reported they are reviewing a draft resolution on the adoption of the Board of Governors Vision for Success goals. She stated; this is an important resolution for our district as their could be financial consequences, if we do not align our local goals with the Vision for Success goals adopted by the Board of Governors in 2017. She added that the draft resolution is being worked on by both colleges and is being vetted through the senates. The aim is to bring the resolution Board for adoption before January 2019. Lastly, the trailer bill accompanying the 2018-19 California State Budget included a requirement that the governing board of each community college district certify that it will adopt goals for the district that align with the Board of Governors Vision for Success goals.

She stated one of their senators recently had to step down, therefore they will be holding a special election. She stated she will report the results at a future meeting.

Lastly, she stated they will be sending two representatives to the Annual Northern Gathering of the Senates event, Friday, October 12th.

Las Positas College Classified, Senate President, Ms. Cindy Robinson reported on the following items:

She stated in August a Retreat was held and they had their first meeting of the year. She stated they will be focusing on shared governance as Classified Professionals and many people are ready to get involved.

PRESIDENT OF STUDENT SENATE OF CHABOT AND PRESIDENT OF ASSOCIATED STUDENTS OF LAS POSITAS COLLEGE

Chabot College Student Senate President, Mr. Lorenzo Caballero reported on the following items:

He thanked Student Senate President Ms. Lylah Schmedel for attending their meeting yesterday discussing plans behind a Unity Project between the two student governments. He added at that meeting they too swore in four new members. He also thanked Mr. Dave Fouquet and Ms. Noell Adams for agreeing to meet next week to discuss the new Funding Formula.

Lastly, he stated a former student senate member composed a video that will be presented at the upcoming October 5th AC Transit Board meeting in efforts to express their concerns regarding the removal of bus 22 line.

Lastly, she stated an election is scheduled for November on their Bi Laws and Constitution. She added, an initiative will be on the ballot as well for a100% Smoke Free Campus.

President Mitzman thanked both Student Senate Presidents, and stated he is happy to see the colleges working together.

Ms. Rachel Ugale, Chapter President SEIU, stated their Leadership meeting is scheduled for Thursday. She stated they are preparing for negotiations and are looking forward to their initial meeting in a few weeks.

She expressed appreciation to HR for facilitating the changes with AB19 Employee Orientation which is legislation that requires public agencies provide unions access to new employee orientations.
