# APPROVAL OF MEMORANDUM OF UNDERSTANDING (MOU) RENEWAL- TRI VALLEY REGIONAL OCCUPATIONAL PROGRAM (TVROP) AND CHABOT-LAS POSITAS COMMUNITY COLLEGE DISTRICT, LAS POSITAS COLLEGE (Agenda Item 4.5)

Trustee Sbranti requested that this agenda item be pulled from the Consent Calendar for further discussion.

Trustee Sbranti stated it was nice to see Tri-Valley R.O.P Superintendent Ms. Duncan this evening and excited about the great work we have done in partnership with them. He stated he is looking forward to further discussions at our upcoming retreat regarding Strong Workforce, CTE, Adult Education, Guided Pathways and what that interface will look like and how we articulate those opportunities for the public.

### APPROVAL OF AWARD OF AGREEMENT FOR COLLEGES' EDUCATIONAL MASTER PLANS AND DISTRICT-WIDE STRATEGIC PLAN (Agenda Item 4.7)

Trustee Sbranti requested that this agenda item be pulled from the Consent Calendar for further discussion.

Trustee Sbranti asked where the Board and students engagement is in the planning and process of the Educational Master Plan.

Interim Chancellor Gerhard stated the Board will be provided continuous updates, recommendations and feedback.

Vice Chancellor of Educational Services Dr. Theresa Fleischer Rowland stated, the Strategic and Educational Masterplan can strategically mobilize us around a vision and our future. She stated pending the Board's approval, we have a consultant group on the Consent Agenda and a planning session is on the calendar. She stated an environmental scan is set for the Spring which will come through our Institutional Research. In addition, she stated they are scaling up workshops that would engage students, classified staff, faculty, all leadership as well as external stakeholders. She added, they too will be working with Public Relations and Marketing to invite employers and residences that are interested in putting input into the vision. She stated as they move forward there are three plans, that will emerge, each college will have Ed Masterplans that will articulate the vision and objective and where they see themselves operationalizing our Mission and the Districts strategic plan which will be done over the summer. She stated a semifinal version that is solid and vetted by the senates and stakeholders will be introduced at the October Board. Lastly, she stated a final version will go to the December Board for approval.

Trustee Sbranti emphasized the importance of working with local industries. He stated as Vice Chancellor of Facilities and Bond Mr. Letcher continues to do his work on the facility side and we are ensuring our Ed Master Plan is done in constant review and in conjunction with Facility Masterplan updates.

Trustee Randolph asked that Interim Chancellor Gerhard provide a brief summary on the projects and additional funding that they will generate.

Interim Chancellor Gerhard stated the work on this started more than a year ago when we learned about the funding model and roll back. He stated as a District all the constituents got together and discussed how we can best use this money understanding that it is one time in nature and furthers the colleges and the District as a whole so when we get out of hold harmless were solid. He stated through the process several applications were received and the Funding Formula Committee vetted and evaluated them based on the rubric. He stated the supporting document that was provided with this agenda item is 11 projects that were recommended by the Funding Formula Committee then to the Planning and Budget Counsel and Chancellor that I am supporting and approving. He stated looking at the bottom line, through these 11 projects the District is in a better place of 2.5 million dollars in terms of ongoing revenue which is the impetus behind this call to action. He stated the Board will receive Budget Transfers to support the allocating funds for projects such as these in the future.

### 1.9 PRESENTATION: CALIFORNIA STRATEGIES, STRATEGIC CONSULTING AND PUBLIC AFFAIRS FIRM

Interim Chancellor Gerhard introduced Director, Public Relations, Marketing and Government Relations Ms. Nunez.

Ms. Nunez stated the presentation from California Strategies will be high level, they will share their goals, deliverables and their perspective advocacy strategy to support our District priorities. She stated as we have conducted our SCFF Advocacy in the past few months, it has

become apparent we needed to go deeper within our efforts to achieve some sort of reform. She stated consistently throughout the past few months as she and Interim Chancellor Gerhard met with officials, Cal Strategies was the firm that was recommended. She stated the Interim Chancellor's vision is Cal Strategies will complement our current work with our Government Relations and SCFF Advocacy. She stated our goal is Cal Strategies will help us expand and penetrate a variety of different government stakeholders both in the Bay area and Sacramento as well. She introduced Ms. Leslie Rodriquez and Ms. Monique Ramos who gave the following presentation:

#### Questions and Comments:

Trustee Sbranti stated he is looking forward to working with Cal Strategies and having this level of coordination is important. Ms. Rodriguez stated they also have partners in Los Angeles and San Diego in high cost areas and have the ability to expand that coalition to other Community College Districts that would be interested in seeing the reform of the SCFF. Trustee Sbranti stated its now a matter of executing and cross referencing those high cost districts in Southern California with which legislators their apart of and building that coalition working through leadership.

Trustee Heredia stated the level of work that is planned is good for all students.

Trustee Granger asked where are we with identifying partnerships with the other College Districts to join the coalition, and what is the timeline.

Interim Chancellor Gerhard stated effort has been focused on attending the Governor's Oversight Committee. He stated we have been exerting our efforts by our Institutional Research, College Presidents, Faculty and Classified Professionals which has been effective in changing the direction in the conversation with the Oversight Committee. He stated, without that level of engagement and consistent attendance the direction that its currently going would be much different. He stated conversations have taken place with elected leaders both here in our Districts and Sacramento. He expressed in his opinion with the energy that has been made on both sides, not only do we need our colleagues around the Bay 10, but we need a constant presence in Sacramento at these committee meetings. He stated having someone that is constantly in Sacramento and has built in relationships benefit us, not only for the Centered Funding Formula and the Advocacy but other things as well. He added, conversations have taken place with other CEOs in the Bay area on joining a coalition of Districts that would be interested in advocating. He stated the CEOs expressed interest but are waiting to see what the Governor's Budget Proposal is. Lastly, he stated a second

CEO, Trustee meeting has been scheduled at Chabot College in February which nine Districts will be attending and this topic will be at the forefront. Trustee Granger asked if the commitment from the other District CEOs will be coming at the end of February. Interim Chancellor Gerhard stated the goal is to come out of the February meeting with a commitment. President Maduli stated he sees this as more of a long-term relationship not just this fiscal year with the Budget Proposal and a May revise. He stated we are on hold harmless through 2023 and we want to position ourselves we don't want lose the revenue were being held harmless. He stated if we can capture back 90% that would be great. Lastly, he stated the focus of the discussion with our coalition partner's needs be we move towards a long-term strategy not just short-term. Interim Chancellor Gerhard stated De Anza and Foothill Community Colleges are facing the biggest cuts and have started cutting sections. President Maduli stated given the data we have, a multiyear strategic plan is necessary to make us whole. Trustee Sbranti agreed with President Maduli this is a longer term arrangement, this is not a single issue coalition. He stated he wants Chabot Las Positas Community College viewed as the "Thought Leader in the State".

Trustee Randolph asked who the partner organizations are that Cal Strategies plan to work with. Ms. Rodriguez stated first, the coalition of the other Districts as well as many great partner's in the Tri-Valley, Chamber of Commerce, Silicon Valley Leadership Group to name a few. Ms. Ramos stated in addition, there are several organizations and coalitions in Sacramento where we can get larger equity.

Trustee Gin stated he learned a lot from the presentation and commended Cal Strategies for their experience locally and statewide. He asked if they have relationships at the federal level. Ms. Ramos stated yes they have partners with expertise at the Federal level.

Las Positas College Student Trustee Mr. Jakob Massie stated he is excited to see this plan role out. He asked if he can recommend Cal Strategies services to other Community Colleges. Ms. Ramos stated yes.

President Maduli thanked Cal Strategies for their presentation.
