Program, Grant Award No. P335A090192, Chabot College

<u>Background</u>: Chabot College applied for and has been selected by the U.S. Department of Education to receive FY2008-09 Congressional directed grant funds under the Child Care Program, Grant Award No. P335A090192.

This grant funding from the Child Care Access Means Parents in School (CCAMPIS) program will be used to support our campus-based child care program designed to serve the needs of low-income students enrolled at our institution and to enable them to pursue postsecondary education at both Chabot College and at the California University at East Bay. These funds will benefit families and children by strengthening the quality of the program through re-engagement in the National Association for Education of Young Children (NAEYC) accreditation process, increasing collaboration between the College's Early Child Development (ECD) faculty and Child Care staff, and improve the quality of instruction. CCAMPIS activities will ensure quality care practices that have significant correlations to quality care and retention for student-parents.

Year one of the four-year grant has been awarded in the amount of \$43,159 for the period October 1, 2009 through September 30, 2010.
