



Discover the cultural and scientific achievements of Peru's 1984 (1994), with Begin in Lima, Peru's capital, home to notable museums and knowners, the the Plaza de Armas. Explore Cuzco, known as the Archaeologica for the Americas. Delve into the mysterious "lost city" of Mactic, for the with architectural wonders and stunning natural beauty, to discover the impressive scientific achievements, including an elaborate road system.

#### Day 1 Flight

Flight to Lima • Board your flight to Lima, capital of Peru. After you arrive and clear customs, meet your EF Tour Director, who will accompany you throughout your stay.

#### Day 2 Lima


Guided sightseeing of Lima • Built on a coastal oasis at the foot of the Andes, Lima has served as Peru's capital since 1535. Your local guide shows you vestiges of the city's rich colonial heritage, including the Government Palace, the Plaza Mayor, the city's cathedral and the 17th-century San Francisco Monastery. Prior to the Spanish conquest, the area was home to several civilizations, such as the one that built Huaca Huallamarca, a pre-Incan pyramid you'll view on your tour. Later, get a taste of contemporary Lima with a visit to the suburbs of San Isidro and Miraflores, which overlooks the Pacific.


Guided visit to the Archaeological and Anthropological Museum • On a guided visit to this fabulous showcase of Peru's pre-Spanish native cultures, see the Raymondi Stone Slab and the Tello Obelisk, along with other outstanding examples of att and archaeological artifacts.

#### Day 3 Lima • Cuzco

Flight to Cuzco • Board your flight to Cuzco, center of the once-powerful Inca Empire.

Guided sightseeing of Cuzco • In the Quechua language, the name "Cuzco" means "navelof the Earth." The Inca named it when this city ruled over a vast empire stretching from Colombia to Chile. Your guided tour starts at the Korikancha Temple, scene of Incan religious rites in bygone times. Later, go inside the cathedral, which sits atop the ruins of an Incan pyramid. Continue to the outskirts of Cuzco and the Sacsayhuaman fortress, which overlooks the city. You'll also see the ruins at Kenko, Puca-Pucara and Tambomachay.

#### Day 4 Cuzco

Excursion to Pisac . At the entrance to the Sacred Valley lies Pisac, a traditional Indian market town. On your way, admire the incomparable beauty of the Cordillera. In the afternoon, visit Ollantaytambo, the oldest continuously occupied settlement in the Americas. The town retains its Incan heritage with exquisitely preserved canals and narrow streets.

#### Day 5 Machu Picchu

Excursion to Machu Picchu • Catch a morning train for a tour of Machu Picchu, the "Lost City of the Inca." Archaeologists have yet to termine why the city, perched atop a mistrouded peak, was abandoned or forgotten. Some believe only an elite class of the Inca priesthood ever knew of its existence. You'll see remnants of temples and terraces that have yet to reveal the true purpose of Machu Picchu.

#### Day 6 Machu Picchu . Cuzco

Morning walk in Machu Picchu . The Inca Trail winds about 27 miles through desert, cloud forest and an orchid-filled jungle before reaching the fabled "Lost City of the Inca." As you hike to Intipunko, you'll quickly understand why it's known as the "Gateway to the Sun." Take in the stunning views from 8,860 feet. Nearby Huayna Picchu, or the Young Mountain, at 9,000 feet, also offers panoramic glimpses of the entire area. Spend time walking through this wonder, complete with fountains, terraced hillsides and livestock.

Return to Cuzco . This afternoon, enjoy a train ride back to Cuzco, where you will spend the night.

#### Day 7 Cuzco

Free day in Cuzco . Spend your final day in Cuzco exploring on your own. You may choose to join our optional river-rafting trip or go horseback riding in the Sacred Valley. You can ask your tour director for more suggestions.

Optional river-rafting trip . Choose to ride the gentle rapids of the Urubamba River, highly recommended for rafters of all ages and abilities. (This optional is available April-September).

#### Days 8-9 Cuzco • Lima • Home

Flight to Lima . After a buffet breakfast, your tour director assists with the transfer to the airport, where you'll board your flight to Lima.

Flight home . Connect to your return flight home, arriving on Day 9.

#### **EXTENSION**

#### Day 8 Puerto Maldonado

Flight to Puerto Maldonado . Board your flight to Puerto Maldonado, the capital of the Madre de Dios region. Located in the Amazaon Rainforest at the confluence of the Tambopata and Madre de Dios rivers, the small frontier town was founded more than 100 years ago during a latex rubber boom. The town also has a history of logging, gold prospecting and oil exploration.

Arrival at an area lodge . Transfer by boat to an area lodge, a camp-style accommodation (please note that the lodge does not have electricity) that provides unparalleled access to Peru's incredible biodiversity. Following a briefing on the lodge and ecotourism, you can enjoy a boat ride, bird watch, take a leisurely walk and take in the nature that surrounds you.

#### Day 9 Puerto Maldonado

Free time . Enjoy free time today participating in ecotourism workshops or exploring the region by foot or boat!

#### Day 10 Puerto Maldonado

Flight to Lima . Your tour director assists with the transfer to the airport, where you'll board your flight to Lima.

Flight home . Connect to your overnight flight home, arriving on Day 11.

# MEMORANDUM OF UNDERSTANDING Travel Study Tour "Peru: Land of the Inca" FEBRUARY 17 SAL

This memorandum of understanding is entered into January 19, 2010, by and between the Chabot-Las Positas Community College District (hereafter "the District") and (Agency) EF Cultural Travel, Ltd., Haldenstrasse 4, Lucerne, Switzerland (hereafter "the Agency").

The Agency intends to provide travel services to District students and faculty in connection with a travel study, offered by Las Positas College April 2, 2010 through April 9, 2010. Such services may include but are not limited to: air transportation and excursions such as comprehensive sightseeing tours, walking tours and/or sightseeing cruises and are detailed in the Scope of Services, attached to this Memorandum of Understanding as Exhibit A, and by this reference made fully a part of the Memorandum of Understanding.

This Memorandum of Understanding is descriptive of the parameters of the proposed trip, as already contracted by Agency with Instructor and Trip Participants. There can arise, in existing world travel conditions, an occasional extenuating circumstance which can force modifications in the travel schedule or accommodation of an individual or group of travelers, e.g., illness requiring layover or hospitalization. In those circumstances, representatives of the Agency and the District would review these extenuating circumstances on a case-by-case basis.

The Agency has received and reviewed, fully understands and, as full consideration for the right to provide the aforementioned travel services hereby agrees to be bound by this Memorandum of Understanding and to be bound by and take all reasonably necessary steps to enforce the District's Policy Concerning "Instruction and Education Program" Section A Subsections 6216 (Field Trips) and 6217 (Travel Study Program) and the District's "Instruction and Education and Education Program--Administrative Rules and Procedures" Sections 6216 (Field Trips). Both the aforementioned policy and the aforementioned Administrative Rules and Procedures are attached to the Memorandum of Understanding as Exhibits B and C respectively, and by this reference made fully a part of the Memorandum of Understanding.

The District understands that all Tour Participants will be required to complete the Agency's application materials, which includes a Release and Agreement.

The Agency and the District agree that the Agency is an independent contractor and not an employee, agent, joint venture or partner of the District. Nothing in this agreement shall be interpreted or construed as creating or establishing the relationship of employer and employee between the District and the Agency or between the District and any assistant, associate, employee or agent of the Agency. Both parties acknowledge that Catherine Suárez is not an employee of the Agency.

Agency agrees to maintain commercial general liability insurance which provides coverage for any covered claims by participants relating to the tour. The District shall be named as an additional insured on such policy.

The Agency shall comply with all applicable laws, ordinances, rules and regulations adopted or established by federal, state or local governmental bodies or agencies.

This Agreement shall be deemed to have been made and entered into by the parties at Pleasanton, California and shall be construed according to the laws of the State of California.

Any litigations arising out of this Agreement shall be filed in the appropriate court in the County of Alameda, State of California.

No amendment, alteration or variation of the terms of this Agreement shall be valid unless made in writing and signed by both of the parties hereto.

Each party hereby represents and warrants that each has full power and authority to enter into and perform each of their respective obligations under this Agreement and that the person signing this Agreement has been properly authorized and empowered to enter into this Agreement. Each party acknowledges that each has read, understands and agrees to be bound by this Agreement.
