Subject: Adoption of Resolution No. 09-1011—Approval of Standard Agreement No. 28114 with the State of California, Department of Rehabilitation, Las Positas College

Background: Las Positas College has had a community partnership with the Department of Rehabilitation (DOR) for over the past five years. This community partnership involves both parties co-locating at the current Tri-Valley One Stop (TVOS) Center whereby allowing the Department of Rehabilitation clients to benefit from the TVOS Center services. The DOR's shared cost is for office and common area space.

This is a two-year standard agreement (No. 28114) from July 1, 2010 through June 30, 2012 with a projected contract amount of \$12,577.44 and a yearly amount of \$6,289. The reason for the lateness of this standard agreement is due to the fact that the State of California did not approve their budget until late Fall 2010.

As this community partnership is with a State of California office, the Board of Trustees is asked to approve the attached Board Resolution for Standard Agreement No. 28114 as well as approving and signing the Contractor Certificate Clauses (CCC).

Recommended Action: That the Board of Trustees adopts the proposed Resolution No. 09-1011 to approve the Standard Agreement No. 28114, with the State of California, Department of Rehabilitation, for the use of office and common area space from July 1, 2010 through June 30, 2012 with a two-year amount totaling \$12,577.44. It is further recommended that the Board authorizes the Vice Chancellor, Business Services, to execute the agreement and any future augmentations or amendments to the agreement on behalf of the District.
