PLACE

Chabot-Las Positas Community College District, Chabot College, 25555 Hesperian Blvd., Hayward, California.

CALL TO ORDER

The regular meeting was called to order at 4:33 p.m. by Board President Dr. Gin. Recording Secretary Beverly Bailey called the roll. Trustees Dr. Cedillo, Dr. Mertes, and Mr. Vecchiarelli were absent at the time of roll. Trustee Dr. Mertes was excused.

PUBLIC COMMENTS

Mr. Dave Fouquet, Chabot-Las Positas Faculty Association, spoke to the Board regarding the Institutional Planning and Budget Model (IPBM), Budget Allocation Model (BAM), and Accreditation. His comments were offered as a follow-up on comments made by colleagues at Las Positas College at the September 16 Board Meeting. He reported that the faculty at both campuses continue to be concerned that the BAM has in its first two years systematically underfunded the colleges. He noted that the process by which the BAM is reviewed needs to do more to ensure the restoration of programs and services lost during the recession, and to consider, as part of the review process, whether the colleges have sufficient resources to improve student learning. On a positive note, he reported that the meeting of the Planning and Budget Committee (PBC) on October 3 was a step in the right direction. At that meeting, the committee crafted a philosophy statement to the effect that we will make decisions that reflect our institutional priorities, specifically student learning, student success, completion of educational goals, and community engagement. In addition, the statement states that resources will be distributed based on clear communication regarding available funding and the needs at each site. He reported that this philosophy is a significant culture shift in this District; noting that never before has the Allocation Model concerned itself with things such as student learning and program needs. He reported that this change is needed, not just to meet our fiduciary obligation to the community, but also to meet accreditation standards. ACCJC evaluators repeatedly ask questions such as: Are items focused on student learning given appropriate priority? Are funds allocated in a manner that will realistically achieve the institution's stated goals for student learning? He reported that because this is a culture shift, we are dependent on Chancellor Jackson to make sure the shift happens, noting that the IPBM is a good start. He expressed that his worry is that there is still

a sense of momentum of doing things the “old way.” The number one goal needs to be ensuring that programs and services are adequately funded at the colleges. He expressed that a serious concern is that even though the District as a whole is enjoying increased funding levels, the colleges are still receiving less per FTES, from the BAM, than they were at the height of the recession.

Ms. Kathy Kelley, President, Chabot College Faculty Senate, spoke to the Board regarding the law that requires Participatory Governance at community colleges; noting that it means all constituents should be included in the process of making decisions, and all ideas and needs should be considered. She reported that this is also expected by Accreditation. She reported that Chabot College will work on its Participatory Governance Policy at a series of three Retreats; the first scheduled for October 23. She expressed that she believes that all voices are heard at the College. She expressed concern we could have the same thing at the District level with the opportunity for meaningful input. She reported that numerous budgetary decisions have been made that do not serve the Participatory Governance process. She expressed that she would like to see positive attitudes going forward and that all, whether Faculty, Classified Professionals, Administrators, or Trustees, be fully participatory; and all our potential realized, as well as meeting our Accreditation recommendations.

ADJOURN TO CLOSED SESSION

Dr. Kritscher noted that in all of the three TRIO Programs, the Student Outcomes have been met and exceeded. He noted that in the ASPIRE Program, the persistence rate is 88%; and a 65% persistence rate between the first and second year. In addition, he noted that the GPA of the students in the program is 3.11 vs. the average of 2.72 for similarly eligible students.

California Education Policy Fund – A Project of Rockefeller Philanthropy Advisors

Fiscal Agent: Chabot College

Total Funding: \$400,000

Annual Award: \$200,000

Project Period: September 1, 2014 - August 31, 2016

- Supports the California Acceleration Project (CAP) to create a statewide blueprint for transforming placement and remediation to increase the proportion of students who complete college-level math and English in their first year;
- CAP will convene a task force to draft a set of recommendations for California Community Colleges, disseminate task force recommendations through key statewide venues, and provide technical assistance to a small group of California Community Colleges to implement these recommendations.

Dr. Hern reported that a serious problem is low completion rates in math and English – 41% vs. 70%. She provided a forthcoming article which she wrote from Board Focus, a trustee publication of the Community College League of California, November 2014 issue– “Moving the Needle on Student Completion.”

PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES ASSOCIATED STUDENTS

Mr. Jesse Esquire, President, Student Senate of Chabot College, reported that the Senate is working on securing discounted bus passes for students. In addition, he reported the Senate is planning a Thanksgiving Dinner for students; as well as a Toy and Food Drive for the Holidays. Further, he reported that he and one of his counterparts will be attending the upcoming (November 14-16) Student Senate for California Community Colleges (SSCCC) Conference in Los Angeles.

Mr. Rafi Ansari, President, Associated Students of Las Positas College (ASLPC), reported that ASLPC recently held a successful Club Day on October 8, with 30 active clubs on campus. He also reported that ASLPC will meet soon to review its Constitution and By-Laws. In addition, he reported that a student survey was recently distributed asking students what services and programs they like. In addition, he reported that a Health Fair will be held in November, date to be determined. Further, he reported that the Director of Legislation has organized a Voter Information Session on Wednesday, October 29, with many candidates attending.

Dr. Susan Sperling, President of Chabot College, introduced her assistant, Ms. Kirti Reddi. Dr. Sperling reported that Dr. Jackson has focused the Colleges on the great opportunities offered by the new Regional Consortia; noting that it is the wave of the future in Community College funding. She also reported that she recently attended a meeting of the AB 86 Career Pathways Trust, noting that the Chancellor is a member of the policy making executive board. Further, she reported that there are several College-wide retreats scheduled to discuss the shared governance process at the college.

Dr. Barry Russell, President of Las Positas College, provided a written report “Las Positas Connection.” He had no formal verbal report.

CHANCELLOR REPORT

Dr. Jannett Jackson, Chancellor, expressed appreciation to Mr. Dave Fouquet and Ms. Kathy Kelley for their Public Comments earlier this evening. She reported that the District will get better in regards to the Budget Allocation Model as it moves forward. She reported that she is looking forward to the upcoming Veterans Event, noting that Mr. Todd Steffan always does a great job. She will also be speaking to a women’s group of the Coast Guard in Berkeley. She reported that she and three Trustees (Dvorsky, Gin, and Mitzman)

will be leaving tomorrow morning for the Trustee Convention in Chicago, where they will be presenting on the Association of Community College Trustees (ACCT) training session “Governance Institute for Student Success” (GISS) held at Chabot College in March.

TRUSTEE REPORTS AND/OR OFFICIAL COMMUNICATIONS

Trustee Dr. Mitzman expressed that he is looking forward to coming back from Chicago and sharing information. He reported that as a member of its Board, he is working with the Salvation Army putting up a tent on A Street in Hayward. He reported that the Sprinkler Local 43 Tour was a great experience, and expressed appreciation to Ms. Julia Dozier for making the arrangements. He noted that he would be in favor of expanding that program.

Trustee Mr. Gelles expressed appreciation to Ms. Julia Dozier, noting the importance of grants. He also recognized Mr. Lorenzo Legaspi for his work; and Mr. Todd Steffan, Las Positas College Veterans Program; as well as the Chabot College Veterans Program. In addition, he expressed to Dr. Maria Ochoa that he hopes to attend the upcoming Gala, noting it is a fabulous way to start. Further, he requested that the District and Colleges look at security, noting the importance of having enough staff in that department to ensure the protection of students and staff.

Trustee Mr. Vecchiarelli reported that he believes there is a way around paying high costs for Trustee Elections; and will provide the information to the Chancellor’s Office.

Student Trustee Ms. Dolorito reported on a recent successful Transfer Day held at Chabot College. She also reported that on this date the Chabot College Health Center held a Wellness Event. In addition, a Halloween (smash ball) event is scheduled. She asked if there is a way to help fund Tutoring for students at both colleges. Further, she reported that Chabot College is working on a water filter system similar to what Las Positas College has in the hopes of reducing plastic bottle water consumption and waste.

Student Trustee Mr. Bolin reported that ASLPC recently (October 2-5) attended the American Student Government Association National Student Leadership Summit in Washington, D.C. He noted that at the summit, they shared ideas, received training, and networked with peers from colleges and universities nationwide. He also reported on an upcoming Neon Night to be held in November. Further, he reported that ASLPC will hold an Effective Leader Workshop Retreat on October 31.
