The California Department of Education (CDE), Early Education and Support Division (EESD) has completed its review of applications submitted in response to the Request For Applications (RFA) for California State Preschool Program (CSPP) Expansion Funding. We are pleased to inform Las Positas College that your application received a score of 121. As set forth in the RFA instructions, all applicants with a score at least 105 points or higher are eligible for CSPP funding. Because the amount of funding authorized pursuant to the Fiscal Year (FY) 2015–16 Budget Act for CSPP expansion funding for Local Education Agency (LEAs) exceeds the amount of funding requested in all applications received, your agency will automatically receive the proposed award amount indicated above. This offer of funding is made pursuant to Management Bulletin 15-10, for sites listed on Attachment A.

While EESD regulations pursuant to Title 5 of the *California Code of Regulations* Section 18003 provides for an appeal process for agencies to appeal their score, in this case, all eligible agencies are being funded so there is no need for an appeal process. Thus, this letter serves as both the notice of your agency's score as well as notice of a proposed award of funding.

The effective date of the FY 2015–16 funding was January 1, 2016. The amount of the proposed award represents the funding necessary for program operation for the period January 1, 2016, through June 30, 2016. Your FY 2016–17 award will be the annualized (July 1, 2016, to June 30, 2017) amount indicated above, contingent upon the availability of funds in the FY 2016–17 Budget Act. Final contract terms, which may include minor adjustments to the award amount, will be negotiated between your agency and the CDE Child Development Fiscal Services (CDFS) unit. A representative from the CDFS unit will contact your agency to finalize the contract terms.

Your agency will be mailed a contract for your signature upon completion of contract negotiations. Any costs incurred outside the performance period of a fully executed contract will not be reimbursed. Contracts for subsequent fiscal years (July 1 through June 30 annually) are renewed each spring, subject to successful performance and availability of funds.

Congratulations on the submittal of a successful application. Your commitment to provide CSPP services to eligible children is highly commendable. The EESD looks forward to maintaining an ongoing positive relationship in support of families and children of California.
