### Dr. Susan Sperling, President, Chabot College reported on the following:

Warm welcome to our newly appointed Trustees.

Update on Neighborhood Promise Grant which ended last year after 5 years of very interesting work on behalf of the Jackson Triangle neighborhood in Hayward. We are working with our Community Partners, Cal State University East Bay, Hayward Unified School District and City of Hayward, to move forward with an extension grant.

She also reported that Convocation Day was received very well by her staff, great job to District Staff who was largely responsible for the coordination of that day. The focus on students was very heartfelt. It was wonderful to see the Trustees there and also Dr. Jackson.

She reported today was College Day on campus, a handout was given to everyone on the dais highlighting the events. One of the highlights was there Keynote Speaker Dr. Kent Wong who is a Professor and Director of Labor Studies/ Ethnics at UCLA. He has been very supportive in studies for Immigrant Students across the State.

She reported that Ralph Nader will be coming to speak on Democracy Day September 14<sup>th</sup> and all are invited, including community members as it will be open to the public.
