

MEMORANDUM OF UNDERSTANDING

AMENDMENT 2

CAREER PATHWAY TRUST, ROUND 2

PARTNERSHIP AGREEMENT

Between

SAN JOSÉ EVERGREEN

COMMUNITY COLLEGE DISTRICT - WORKFORCE INSTITUTE,

AS LEAD AGENCY

AND

LAS POSITAS COLLEGE

- 1. This amendment (the "Amendment") is made by SAN JOSE EVERGREEN COMMUNITY COLLEGE DISTRICT; WORKFORCE INSTITUTE ("SJECCD-WORKFORCE INSTITUTE") and Las Positas College ("PARTNER") parties to the CAREER PATHWAY TRUST, ROUND 2 PARTNERSHIP AGREEMENT dated JULY 1, 2015 (the "Agreement").
- 2. The Agreement is amended as follows:

1. PREFACE

The effective date of this AGREEMENT is July 1, 2015 ("EFFECTIVE DATE"). AGREEMENT remains effective until it terminates on June 30, 2020 ("TERMINATION DATE"), as provided herein (collectively, "AGREEMENT PERIOD"). Based on the no-cost extension approved by the California Department of Education (CDE), all funds must be spent by April 30, 2019 the remaining of fiscal year (FY) 2018-2019 and FY 2019-2020 will be sustainability years.

2.1 PARTNER'S OBLIGATIONS EVALUATION

Specifically, California Career Pathway Trust (CCPT) direct grant will be thirteen-million, one-hundred seventy-three thousand, one-hundred fifty-three dollars (\$13,173,153) over the 4-year grant term and in-kind/matching resources for sustainability over up to a 2-year period, through June 30, 2020.

For partners completing the project on June 30, 2018 or anytime prior to April 30, 2019 the sustainably period will be FY 2018-2019 and FY 2019-2020. For partners extending their funding to April 30, 2019 the sustainability period will be the remainder of FY 2018-2019 and FY 2019-2020.

PARTNER shall submit a maximum of four (4) invoices per fiscal year for the term of this agreement (July 1, 2015 to June 30, 2020). However, the payment schedule for the agreement is from July 1, 2015 to April 30, 2019.

EXHIBIT B: BUDGET SCHEDULE

The adjusted MOU total was \$550,000. As of June 30, 2017 PARTNER had a remaining allocation of \$256,895.86. PARTNER shall continue to submit a maximum of four (4) invoices per fiscal year for the remaining term of this MOU (FY 2017-18 and FY 2018-19). The last invoice must be submitted no later than April 30, 2019. Fiscal year 2019-2020 is a sustainability year; PARTNER shall submit a maximum of

four (4) match statements. In the event PARTNER utilizes all funds prior to April 30, 2019, the remaining months of FY2018-19 will be considered sustainability.

3. Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is conflict between this amendment and the Agreement or any earlier amendments, the terms of this amendment will prevail.
