# 1.9 PUBLIC HEARING: PUBLIC HEARING ON THE MASTER OPERATING AGREEMENT BETWEEN CHABOT-LAS POSITAS COMMUNITY COLLEGE DISTRICT AND THE LAS POSITAS COLLEGE VITICULTURE AND ENOLOGY FOUNDATION, A DISTRICT AUXILARY ORGANIZATION.

Vice Chancellor Johns stated the establishment of a community college district auxiliary organizations is regulated by law. They are formed to provide specified services, programs or functions in support of a district as set forth in a written agreement The Board holds responsibility over auxiliary organizations as to meeting legal requirements and fulfilling the terms of the agreement between the organization and the district.

In accordance with Board Policy 3600, recognition and establishment of auxiliary organization first requires a public hearing. The Board then recognizes of the auxiliary organization describing the services, programs or functions to be performed. Upon the approval by the Board of Trustees, the approved agreement must then go to the State Chancellor's Office for review and approval before it takes effect.

President Mitzman thanked Vice Chancellor Johns for her report.

Trustee Gelles asked if there have been many problems with auxiliaries over the and if legal counsel reviewed this. Interim Chancellor Cota stated yes, the college has been reviewing this for several months. Trustee Gelles also asked if officers are required. VC Johns stated in agenda item 4.11 the Articles state who the Board members are, including the college presidents and program leads.

President Mitzman opened the Public Hearing at 6:57 p.m. with the declaration that the Master Operating Agreement between Chabot-Las Positas Community College District and the Las Positas College Viticulture and Enology Foundation, a District Auxiliary Organization. Hearing no comments, he closed the Public Hearing at 6:58 p.m.

# Questions and Comments:

Interim Chancellor Cota suggested the Board take a close look at the Special Reserve Funds and see how they were meant to be spent.

Trustee Maduli asked if the Self Insurance Fund figures presented are to establish a Trust Fund for OPEB. Vice Chancellor Gerhard stated, yes. The District is in the final stages of releasing a Request for Proposals to evaluate programs around the state to set up an irrevocable trust. Trustee Maduli asked, if we set funds aside for the STRS/PERS for the Major Expenditures Assumptions or did we use this to balance the budget. Vice Chancellor Gerhard stated, we set funds aside in our Budget Allocation model which were distributed through position control and are reflected in the benefit numbers presented tonight. Additionally, he stated the PERS is scheduled to go up to 24.6% in fiscal year 2021. He further stated, as of right now we don't have money to fully fund going from 18.06% (where we are right now) to 24.6%. Trustee Maduli response, that is a concern we need to address in the next few years. He then questioned the Chabot Colleges deficit. Vice Chancellor Gerhard stated, Chabot College continues to rebuild according to the plan presented to the Board of Trustees in October 2017. For fiscal year 2017-18, Chabot's Unrestricted General Fund ended with a surplus of \$399,828. Further, the 2018-19 budget includes a surplus of \$614,529. This means, over a two-year period Chabot will have rebuilt its college reserve by over \$1 million.

Trustee Gelles asked why in 2017-18 the District's Unrestricted General Fund balance decreased by \$6.98 million. Vice Chancellor Gerhard stated most of this is attributed to the fact that we fully funded the SERP cost last year instead of paying for it over five years. We budgeted \$700,000 but actually paid \$3,856,887, a swing of \$3.1M. The other largest contributing factor was we were chasing FTES. Because of this we overspent on faculty salaries and benefits by \$2.9M. Moreover, he assured the Board not to be worried as that

was a one-time occurrence. Trustee Gelles stated he is looking forward to hearing the presentation at September 4<sup>th</sup> Study Meeting.

Trustee Randolph asked if the Budget is balanced, Vice Chancellor Gerhard stated yes. The Unrestricted General Fund budget is balanced, with a surplus of \$3.2M. Trustee Gelles piggybacked Trustee Randolph's question and asked if they are budgeted at both schools. Vice Chancellor Gerhard answered yes.

Trustee Randolph furthermore asked Vice Chancellor Gerhard if he has any concerns at this time, Vice Chancellor Gerhard stated as a District we need to focus on what will be discussed at September 4<sup>ths</sup> meeting and looking at the state model changes and how it may impact us. He also stated data is being reviewed and conversations are underway at the colleges. Ultimately that information and results of those conversations will elevate up to Board level as Trustee Randolph stated she is confident with Vice Chancellor Gerhard leading us we will get to where we need to be.

President Mitzman asked if the colleges are running in the deficit. Vice Chancellor Gerhard stated no. President Mitzman stated he is looking forward to the September 4<sup>th</sup> Study Meeting.

Trustee Maduli mentioned the new Funding Formula Trailer Bill requirement for adoption of goals aligned with the Vision for Success, which has to be approved in December. He asked whether the District has begun working on the goals. Interim Chancellor Cota asked/directed VC Johns to respond. Vice Chancellor Johns stated we've been asked by the state to have goals that align with the Board of Governors goals- the 2017 Vision of Success Goals—in place by January, 2019. These will need to be aligned with our District Comprehensive Plan, which consists of the Educational Master Plans from the colleges, as well as the strategic plan and priorities from the District. The District Senior Leadership has already had conversation around proposed goals; additionally this matter is placed on the September Agenda for the Chancellor's Council, which is a multi-constituency leadership group. We hope to advance a recommendation to Board for adoption this fall. She noted that if the goals are not adopted, in time that will implicate our ability to qualify for certain state funding

President Mitzman thanked Vice Chancellor Gerhard for his detailed report.

He expressed how excited he is with the passing of the MOU for the City of Hayward.

# Chabot College Classified, Senate President, Ms. Noell Adams reported on the following items:

She stated Ms. K Metcalf was presented with the Linda and Robert Carlson Classified Professional of the Year award. K has worked for Chabot College since 2007 as an Instructional Assistant II and she leads Chabot's Student Online Services Center. She also served as Chabot's SEIU Vice President and as a senator in the Classified Senate.

She stated during Convocation; 70 leaders combined from both senates, paired to facilitate a session for classified professional's title "Classified Conversation". She looks forward to more of these opportunities.

She stated the senate will be discussing and making recommendations regarding the new Funding Formula and look forward to the upcoming Board Study Session September 4<sup>th</sup>.

President Mitzman stated he attended the Ribbon Cutting of Building 1000 at Las Positas College last week and suggest it be named: "Hawks Nest".

# PRESIDENT OF STUDENT SENATE OF CHABOT AND PRESIDENT OF ASSOCIATED STUDENTS OF LAS POSITAS COLLEGE

# Las Positas College Student Senate President, Ms. Lylah Schmedel reported on the following items:

She thanked everyone that attended the Ribbon Cutting of Building 1000, and likes President Mitzman suggestion of it being named "Hawks Nest".

She stated they will be meeting this week with new senators.

She reported they conducted a successful Food Pantry event.

Lastly, she stated they are collaborating with a non-profit organization to organize a Hunger Awareness week in November.

# Chabot College Student Senate President, Mr. Lorenzo Caballero reported on the following items:

He stated he is concerned with AC Transit removing Line 22.He stated this is the only direct line from South Hayward to Chabot College and will affect students significantly, financially and academically should they need to drop classes. He stated to show support, they will have a table in the Cafeteria August 20<sup>th</sup> thru August 23<sup>rd</sup> as well as at Gladiator Day August 28<sup>th</sup> and 29<sup>th</sup>.

He reported their first student senate meeting was conducted yesterday.

He expressed his enjoyment of Vice Chancellor Gerhard's Budget presentation and echoed Trustee Randolph by stating we are all in this together and need to stand in solidary.

#### **GOOD OF THE ORDER**

Ms. Rachel Ugale, Chapter President SEIU, stated it was nice to see all members attend their meeting during Convocation. She stated she is excited about the commitment to collective bargaining, they are currently at 85% member ship.

She stated site member VP Metcalf from Chabot College and herself are serving as delegates from the chapter at the local SEIU 1020 Convention in Concord coming up.

She thanked Vice Chancellor Gerhard and Vice Chancellor Fong for supporting Ms. Joanne Bishop-Wilbur and Ms. Philomena Franco's attendance at the recent Budget Presentation in Sacramento. She is hopeful to use the information they learned for upcoming negotiations.

Lastly, on a personal note she thanked President Mitzman for his opening comment and feels blessed to work with such amazing people and District.

Mr. David Fouquet, President of Chabot-Las Positas Faculty Association, reported it was a pleasure to meet with dozens of new faculty members at the new faculty orientations at both campuses. He stated they have dozens of new FA members.

He expressed sincere appreciation to the Human Resources Department, especially Ms. Jennifer Druley for their hard work in coding faculty members (300 full-time, 700 part-time) correctly in Banner.

He stated he recently attended the Budget Workshop in Sacramento at the State Chancellor's office. He met with individuals from the Finance and Facilities Office whereby he presented some quantitative evidence showing how the "Student Centered Funding Formula" will inflict programmatic harm to districts in high-cost regions (e.g., the SF Bay Area), and thereby harm all students in those districts, including literally hundreds of thousands of low-income students.
