TITLE: CONSIDER A RESOLUTION DECLARING AS SURPLUS ONE POLICE UTILITY VEHICLE AND AUTHORIZE CITY MANAGER TO EXECUTE AGREEMENT DONATING THIS POLICE VEHICLE TO LAS POSITAS COMMUNITY COLLEGE

SUMMARY

The attached resolution itemizes the police utility vehicle proposed for surplus, including description and vehicle identification number 1FM5K8AR2EGB38533 (VIN). This vehicle would be donated to Las Positas Community College.

RECOMMENDATION

Declare as surplus the Pleasanton Police Department police utility vehicle VIN 1FM5K8AR2EGB38533 as it has passed its useful and cost effective service life and has been replaced.

Authorize the City Manager to execute an agreement, in a form approved by the City Attorney that provides for the transfer of this police utility vehicle to Las Positas Community College.

Find that such transfer would directly benefit the Administration of Justice Program at the College; several core courses including the Introductory Course, Patrol Procedures, Criminal Investigation, and Traffic Investigation are enhanced by practical, hands-on elements.

FINANCIAL STATEMENT

The transfer, transportation and other logistics of this donation will have no cost to the City of Pleasanton.

BACKGROUND

When Pleasanton Police Department vehicles reach the end of their service life they are surplused. These vehicles are typically five years old and are no longer financially feasible to maintain. Revenue from the sale of these vehicles is estimated by Fleet staff to be \$1,500 to \$2,000 per vehicle.

This donation request supports the community partnership between the Pleasanton Police Department and Las Positas Community College. This will directly benefit the Administration of Justice Degree Program, which is centered entirely on preparing students for job entry with a California law enforcement agency.

WHEREAS, the Pleasanton Police Department surplused a 2014 Ford Police Utility Vehicle, VIN 1FM5K8AR2EGB38533, and

WHEREAS, the Pleasanton Police Department will donate this police utility vehicle to the Las Positas Community College, and

WHEREAS, this sedan has passed its useful and cost effective service life, and is highly desired by the Las Positas Community College for educational purposes.

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF PLEASANTON RESOLVE, DECLARE, DETERMINE, AND ORDER THE FOLLOWING:

SECTION 1. Approves the donation of one surplused police utility vehicle from the Pleasanton Police Department to the Las Positas Community College.


SECTION 2. Authorizes the transfer, transportation and other logistics of this donation will have no cost to the City of Pleasanton.


