This Addendum adds to the contract commenced on July 1, 2019 and October 1, 2020 by and between Chabot Las Positas Community College District, 7600 Dublin Blvd., 3rd Floor, Dublin, CA. 94568, hereinafter referred to as the "District", and Falck, 2190 S. McDowell Blvd., Petaluma, CA. 94954 hereinafter referred to as the "Company" to include Chabot College E.M.S. program as part of the clinical environment.

As per the contract the following will include the District and Chabot College:

Whereas, as a part of the licensing and/or certification requirements, students must complete a course of study including clinical experience ("clinical experience") on an ambulance providing the appropriate level of care and operating in normal service.

Whereas, Company is a provider of emergency medical service, including both advanced life support and basic life support pre-hospital care and transport.

Whereas, Company has agreed to assist District by providing a limited Clinical Experience for students, upon certain terms and conditions, so long as its participation in the program does not jeopardize patient care or compromise Company's standards of service to its patients and clients.

Other than adding Chabot College to the original contract, all other terms and conditions of the "Original" Agreement shall remain unchanged and in full force and effect.
