

**FIRST AMENDMENT TO
STUDENT HEALTH & WELLNESS CENTER AGREEMENT**

This First Amendment (“**Amendment**”) is entered into as of August [REDACTED], 2021 or the date of the last signature, whichever is later (the “**Amendment Effective Date**”) by and between The Hospital Committee for the Livermore-Pleasanton Areas, a California nonprofit public benefit corporation, doing business as Stanford Health Care – ValleyCare (“**SHC-VC**”) and Chabot-Las Positas Community College District (“**College District**”), and supplements and amends that certain Student Health & Wellness Center Agreement by and between SHC-VC and College District dated June 1, 2021 (the “**Agreement**”).

WHEREAS, SHC-VC and College District are parties to the Agreement, pursuant to which SHC-VC provides certain services to College District at its Las Positas College campus (“**Las Positas**”) in connection with the operation of the Las Positas College Student Health & Wellness Center, located at 3000 Campus Hill Drive, Livermore, California (the “**Wellness Center**”), including to provide TB screening and skin testing and influenza vaccination services to College District employees;

WHEREAS, SHC-VC currently obtains the Influenza Vaccination Shots from the County of Alameda at no cost to SHC-VC, and accordingly wish to provide influenza vaccination services to College District employees without collecting a fee. Accordingly, the parties wish to amend the Agreement to reflect the foregoing; and

WHEREAS, it is the mutual desire and intent of the parties hereto to enter into this Amendment upon the terms and subject to the conditions set forth herein.

NOW, THEREFORE, in consideration of the promises and mutual covenants hereinafter set forth, SHC-VC and College District hereby agree as follows:

1. **Employee Fee.** Section 3.10 of the Agreement (Employee Fee) is deleted and replaced by a new Section 3.10 as set forth below:

3.10 Employee Fee. Las Positas will collect from the Human Resources Department an employee health fee (“**Employee Fee**”) equal to the amount of thirty dollars (\$30.00) for each Employee TB Test, except for employees (e.g., student assistants) who are enrolled students and have already paid the Student Fee. Influenza Vaccination Shots will be administered at no charge, to the extent that Stanford Health Care - ValleyCare receives such vaccination shots at no cost.


2. **Continuation.** Except as specifically amended and modified by this Amendment, the Agreement shall continue in full force and effect in accordance with its terms as in existence on the date of this Amendment.

3. **Defined Terms.** Capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement.
