To date, we have begun the first draft for 88 degrees/certificates. We expect that ~60 of those should turn in their documents by the end of Fall
semester. We have the graphic layout for the Program MAPs almost complete and our newly hired student assistant has just begun transferring the
information from the submitted templates into the graphic format. This work is being facilitated by 7 faculty Mapping Navigation Guides and directed by two faculty project leads with support from the Office of Institutional Effectiveness.
