



COVID-19 Disaster Relief Assistance for Undocumented Students and Mixed-Status Families

Dear Students,

We know this may be a difficult time for you and your families, especially due to the Department of Education's regulations over the COVID-19 Emergency Funds that are not available for the undocumented community.

We acknowledge that you and your loved ones contribute greatly to the state of California and deserve assistance during this time of need. We are glad that Governor Newsom is taking steps to support families with the Disaster Relief Assistance funds. The following is information that we have gathered from the <u>State of California</u>:

- 1. <u>Governor Newsom's Announcement</u> of \$125 million in funding for undocumented immigrants amidst COVID-19.
- 2. The California Department of Social Services has selected twelve immigrant-serving nonprofit organizations to help individuals apply for and receive this disaster relief assistance in their region.
- 3. An undocumented adult who qualifies can receive \$500 in direct assistance, with a maximum of \$1000 in assistance per household. Read frequently asked questions.
- 4. Eligible individuals must be able to provide information that they (1) are an undocumented adult (person over the age of 18); (2) are not eligible for federal COVID-19 related assistance, like the CARES Act tax stimulus payments or pandemic unemployment benefits; and, (3) have experienced a hardship as a result of COVID-19.
